**Notes:**

1. The Club membership database is subject to the Data Protection Act 1998.
2. Medical information is defined as sensitive and will only be used for the well being of members while participating in Club activities. Members must notify the Club of ANY changes to medical conditions which could affect their safety when participating in Club activities.
3. Fees are due on the 1<sup>st</sup> of each month for the month ahead, standing orders must be received by 4<sup>th</sup>. If a member fails to participate due to holidays or sickness, fees are still payable as their space is still allocated. If membership fees fall into arrears this may affect eligibility to compete.
4. If a member is leaving the Club they need to inform the Club Secretary in writing of their resignation before the 1<sup>st</sup> of the month. This can be done by email ([sossc@live.co.uk](mailto:sossc@live.co.uk)). If notification of resignation is not received before the 1<sup>st</sup> of the month they will be charged for the fees for that month.
5. ASA Cat 1 registration is included in monthly fees .The upgrade to Cat 2 for competing swimmers is paid at the Clubs discretion. Registration fees are paid upfront by the Club. If a member resigns at any time during the 12 month period they will incur a pro rata proportion of the ASA fee which is payable to the Club on leaving.
6. When setting Club fees, Bank Holidays, Easter and Christmas breaks and occasional pool closures are factored in. The annual fees are then divided into 12 equal monthly payments.
7. Children under 12 years must not be left at the pool without a responsible adult.
8. The Club reserves the right to refuse membership and the reasons of such refusal may not, at the committee's absolute discretion, be disclosed to the applicant.
9. The Club may wish to take photographs for the Club website, local press and other publicity. All photographs will be taken and published in line with the ASA Photography Policy. Videos may also be taken and used for training purposes. If you do not wish your child to be photographed or filmed please advise the Club Secretary on [sossc@live.co.uk](mailto:sossc@live.co.uk).
